

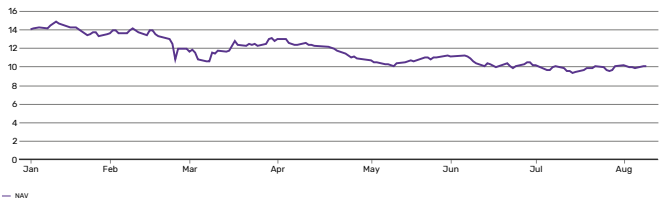

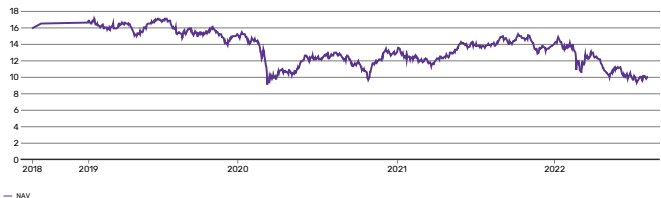
Net asset value - YTD
